Arising out of the Minutes

Arising out of the minutes of the Governing Body meeting held on 04th September, 2020, the Chairman, Governing Body informed the Governing Body that he was authorized to check the legality with regard to request dated 22.01.2020 received from Dr. Shantesh Kumar Singh for waiver of proportionate amount to be refunded with respect to leave salary, allowances and other expenses paid to him by the College during his Study Leave. The Chairman, Governing Body suggested that the Governing Body should take final decision in the matter.

The matter was discussed in detail and the members of the Governing Body noted that Study Leave to Dr. Shantesh was granted with the approval of the Governing Body of the College as per University rules. It was also noted that the Governing Body granted Extra-Ordinary Leave with lien to Dr. Shantesh to join as Associate Professor in the Department of Political Science, Central University of Haryana, Mahendergarh as per University rules. of the Governing Body also noted that Dr. Shantesh has joined his services from one Central University to another Central University and the funding agency to pay the salary and usual allowance is the same.

After discussing the matter in detail, the Governing Body unanimously decided that as an exceptional case, the request dated 22-01-2020 received from Dr. Shantesh Kumar Singh, which was placed before the Governing Body at its meeting held on 4th September, 2020, for waiver of proportionate amount out of Rs.10,09,511/- deposited by him for the salary paid to him during his study leave w.e.f.18-8-2018 to 30-6-2019 be considered and the proportionate amount for the period served by him after joining back his duties from Study Leave, out of amount of Rs.10,09,511/-, be refunded to Dr. Shantesh Kumar Singh with respect to leave salary, allowances and other expenses paid to him by the College.

Arising out of the Minutes

Arising out of the minutes of the Building Committee meeting held on 06th October, 2020, the Principal reported that due to introduction of EWS admissions in the College in different courses, the number of seats for admission have been increased to 3600 approximately in Morning College and 3000 approximately in Evening College for all the three years. For smooth teaching learning in the College, there is requirement of Classrooms and Computer Labs for Morning and Evening College.

The matter was discussed in detail and the Governing Body suggested that the Competent Authority should consult with Staff Association and Staff Council of the College with regard to construction of more classrooms in the College to provide better infrastructure for smooth teaching learning in the College. The Governing Body desired that more computer labs and office infrastructure should be developed on priority basis.
